## **Installing Sensor Batteries**

The sensor is designed to run wirelessly from a remote location off of four (4) AA batteries (not included).





1. Remove the sensor's front cover by removing the two cover screws. Install four (4) AA batteries as indicated.


2 Replace the cover 3. Replace the sun and secure the four blocker on the sensor

## **Adjusting Sensor Settings**

Several switches are contained within the battery compartment which regulate various functions of the unit (i.e. timers, photo sensors, sensitivity). Follow this guide to adjust your unit to the desired setting(s).






1. Remove the sun shade and the four screws holding the sensor cover in place

2. Inside the sensor unit is a battery compartment and the rows of switches which control the sensor settings.

## **Code Matching & Tune Selection**

Step1:Insert the battery into the transmitter to be used (Sensor))

Step 2: Insert the batteries into the receiver (chime ID unit).

- Step 3: Enter pairing mode for the receiver (chime unit). Press & hold the • zone selector button for 3 seconds. The LED in zone #1 will flash.
- Step 4: Press the zone selector button again to move to the zone you wish to pair with. Press the I melody selector button to scroll through the melodies. Once vou hear a melody vou prefer, do not press any button as the melody is set for that zone.
- Step 5: Once the zone & melody are selected, press the test button of the once to pair. If successful, the receiver (chime unit) will generate two tones. Press the • zone selector button to exit the pairing mode, the sy now ready to use. button

## Helpful Tip! Multiple Receiver Conflicts


If you have multiple receivers and they utilize the same signal code, you will need to manually change the code in one or more of your sensors. To do this, remove one of the battery. PRESS and HOLD the "test" button in the sensor battery compartment, insert the battery, HOLD the button for 5 seconds. When the LED flashes five times, a new signal code has been autoamtically generated NOTE: you will have to repair a receiver withe the newly coded sensor(s).

### Installing your Sensor

It is recommended that the motion sensor be mounted 1 meter (3-5 feet) from the groundon a sturdysurface (i.e. a wall or stiff post), and that the "eve" bepointed towardthe target sensing area and slightly downward.


